ANDREWS OLD CEMETERY AND ANDREWS WEST CEMETERY

1. An outside enclosure is not required for each interment, and there will not be 2 burials on top of each other.
2. No monuments shall be set on the weekend or on county holidays or without cemetery personnel present.
3. There is no monument height restriction. No curbs (cornerstones only), no shrubs, flowers, or trees will be allowed.
4. All monuments will need to be made out of granite, marble, or bronze. Monuments made out of concrete, wood, terrazzo, etc. will not be allowed.
5. Vases will be allowed on monument sides only and not on the ground. Small flags are allowed in vases.
6. Monuments at the head of the grave will need to be 4½ foot or less in length and 14 inches or less in width per space.
7. All foot markers need to be set at the foot of the grave, and no more than 1 ½ inches above ground.
8. Live or artificial flowers will be allowed in vases that are attached to the monument or as "saddles". Flowers will not be allowed in front or behind the monument or on the gravesite (Only after interment services).
9. All opening and closing of graves will need to be setup through a funeral home, and no one is allowed to disturb the ground surface by digging or tilling, etc.
10. All flowers that are placed on grave after graveside services will be removed after 3 days.
11. All large standing flags can be purchased thru the Andrews Boy Scouts Flag Program. 432-664-0750 or 432-631-2553

ANDREWS NORTH CEMETERY

1. An enclosure (minimum concrete box) will be required for each interment other than Babyland. This is a county requirement and not a state requirement. There will not be 2 burials on top of each other.
2. Maximum number of spaces sold per family shall be ten.
3. Sections will be opened upon Commissioner's Court approval. The next section shall be opened when ¾ of the current section is sold.
4. All monuments will need to be made out of granite, marble, or bronze. Monuments made out of concrete, wood, terrazzo, etc. will not be allowed. No mourning benches, chairs, etc. will be allowed.
5. Vases will be allowed on monument sides only and not on the ground. Small flags are allowed in vases.
6. Monuments at the head of the grave will need to be 4½ foot or less in length; 14 inches or less in width; and 2½ feet or less in height per space. No curbs (cornerstones only), no shrubs, flowers, or trees will be allowed.
7. All foot markers need to be set at the foot of the grave, and no more than 1 ½ inches above ground.
8. Live or artificial flowers will be allowed in vases that are attached to the monument or as "saddles". Flowers will not be allowed in front or behind the monument or on the gravesite (Only after interment services).
9. Grave covers such as concrete or granite slabs will not be allowed, however, holiday covers (blankets) are acceptable other than during the growing season.
10. All opening and closing of graves will need to be setup through a funeral home, and no one is allowed to disturb the ground surface by digging or tilling, etc.
11. All flowers that are placed on grave after graveside services will be removed after 3 days.

ANDREWS BABYLAND CEMETERY (Located in the Andrews North Cemetery)

1. An outside enclosure is not required in babyland cemetery. There will not be 2 burials on top of each other.
2. The County of Andrews will provide the monument, so we may be able to insure uniformity and have the ability to maintain the grounds. Privately bought monuments will not be allowed on the property.
3. Gravesites will be filled in consecutive order and will not be scattered randomly throughout the area.
4. Grave length for babyland shall not exceed 2 ½ feet in width and 4 ½ feet in length. Otherwise, a regular space will have to be utilized outside babyland cemetery.
5. No trees, shrubs, bushes, or mourning benches, will be allowed in Babyland.
6. All opening and closing of graves will need to be setup through a funeral home, and no one is allowed to disturb the ground surface by digging or tilling, etc. Flowers on the grave after graveside services will be removed after 3 days.

INURNMENT OF CREMAINS (ASHES) IN ALL ANDREWS COUNTY CEMETERIES

1. Cemetery personnel will have to be present for all burial of cremains. Scattering of cremains will NOT be allowed.
2. No more than 2 cremains will be buried on one grave. One cremain will need to be buried at the foot and the other cremain will need to be buried at the head of the grave. Only one cremain will be allowed to be buried at the foot of the grave, if there is already someone traditionally buried on that property. Each cremain will be buried 2 feet from each end of grave and 2 feet below the surface of the ground.
3. All opening and closing of graves will need to be setup through a funeral home, and no one is allowed to disturb the ground surface by digging or tilling, etc.
4. All flowers that are placed on grave after graveside services will be removed after 3 days.
5. All large standing flags can be purchased thru the Andrews Boy Scouts Flag Program. 432-664-0750 or 432-631-2553

INDIGENT COUNTY BURIALS

1. County of Andrews will provide the monument, so we may be able to insure uniformity and have the ability to maintain the grounds. Privately bought monuments will NOT be allowed.
2. Services will be held at 2:00 PM at the graveside only. No church or chapel services will be allowed.
3. No services will be allowed on Saturday, Sunday, or County Holidays.
4. Families will need to contact a local funeral home for eligibility, requirements, and service details.
